By signing this agreement, you also agree to be held personally financially responsible for any damage to the picnic tables arising out of moving the picnic tables.

If you provide any form of amusement at Caseyville Park, including but not limited to, bounce houses or pony rides, you further agree to release and hold the Village harmless from any and all liability of whatever kind arising out of the use of the amusements by anyone. You further agree to be financially responsible for any and all claims arising out of the use of the amusements.

A certificate of insurance will be required to be submitted by you to the Village to confirm that you have liability insurance which covers the use of the amusements by anyone for property damage and personal injury in amounts satisfactory to the Village.
